VI. International conferences of the International sports federation of firefighters and rescuers.

Date of carrying out - on December, 7-10th, 2005.

The place of carrying out - of Togliatti, Russia

Having considered and having discussed a question on payment of a membership dues Conference marks a place of carrying out, that a number of the countries are in arrears on payment of payments: Islamic republic of Iran - 3600 \$, Belarus - 300 \$, Ukraine - 4028 \$, Uzbekistan - 8600 \$, Lithuania - 1000 \$, Kazakhstan - 1000 \$, Mongolia - 9600 \$, Hungary - 1000 \$, Slovakia - 4300 \$, Moldova - 4300 \$, Estonia - 300 \$.
